# USATF Annual Meeting

Decisions have not been made or announced regarding the date, location, or nature (virtual vs. in-person) of the 2021 USATF Annual Meeting. We will keep you informed as information is available.

# **USATF Associations**

USATF is divided into 57 local Associations. All Associations shall be separately incorporated entities, in good corporate standing, and must be recognized by the Internal Revenue Service (IRS) as 501(c)(3) non-profit entities that are not private foundations.

The primary objective of an Association is to assist in the development and growth of the sport of track & field, long distance running, and race walking in the designated Association within its geographic jurisdiction. The Associations are responsible for the local "grass roots" level of the sport, including, but not limited to, individual memberships, organizational memberships (local clubs), event sanctioning, scheduling and coordination of Association championships, and marketing.

# <u>Association Required Documents</u>

Each Association is required, by either the USATF Bylaws or by the Associations Committee Operating Procedures, to maintain or have on file certain documents and records. These documents and records include articles of incorporation or charter, Association bylaws, 501(c)(3) status, a copy of the minutes from the Association's annual meetings, and yearly financial records (990's). Failure to submit such documents to the National Office may result in the decertification of your Association, your Association not receiving delegate credentials at the Annual Meeting, and/or not being able to vote in Association Committee meetings or elections.

# **Association Accreditation**

In order to maintain good standing, an Association must meet all nine (9) of the required standards.

# Standard Requirements:

- 1. Members: 20 per 100k population, Minimum 400
- 2. Clubs: 0.5 per 100,000
- 3. Sanctions: 1.0 per 100k population, Minimum 20
- 4. Championships:
  - 3 T&F Outdoor (Y, O, M)
  - 3 Racewalk (Y, O, M)
  - 3 Cross Country (Y, O, M)
  - 2 LDR, 1 event 5K or higher (O, M)
  - 4 additional championships
- 5. Officials: 30 Certified Officials for Associations of 3 Million or less, Associations between 3 and 10 Million will have a minimum of 1 Certified Official per 100,000 of population, 100 Certified Officials for Associations of 10 Million or more
- 6. Financial Report: Positive net worth as reported on your 990 Forms
- 7. Communication: Meet minimum criteria for Association website, Send either electronically or by mail 2 newsletters per year to full membership
- 8. Association Documents: Current bylaws, Articles of incorporation, Annual meeting minutes, 990 Tax forms from the year previous to the current tax year (two years previous to the current year)
- 9. Representation: 4 Delegates for Associations with populations 2 million or less, 6 Delegates for Associations with populations between 2 and 3 million, 8 Delegates for Associations with populations greater the 3 million

# 2020 Annual Meeting Discussion:

 AAC discussed support for 2020 bylaw amendment to "Keep Olympic Dream Alive and Strengthen the Athlete Voice" USATF Level 1 education has been re-accredited for the next seven years.

#### **Level 1 Recertification Guidelines**

Current certified Level 1 coaches must complete a USATF approved continuing education course each renewal period (in accordance with the schedule below) to maintain certification. Members may verify their certificate expiration date by accessing a copy on <u>USATF Campus</u> (certificates are available under Transcripts).

School Date	Expiration
January 1, 2013 – June 30, 2019	December 31, 2020
July 1, 2019 – December 31, 2020 <i>(waiver period)</i>	December 31, 2024

# **Recertification Options**

The following are approved by the USATF

#### Please note:

- A Level 1 certificate issued prior to December 31, 2012 is no longer current, and coaches will need to register and attend a new Level 1 School to attain certification
- Members who completed a Level 1 during the waiver period do not need to take any action until the next recertification period
- Level 2 and 3 coaches remain exempt from recertification and no action is necessary

Coaching Education Committee and qualify for Level 1 recertification:

- 1. Complete a minimum of one online course on <u>USATF Campus</u>
- 2. Complete a minimum of one USATF specialty course or clinic
  - 1. USATF Learn By Doing Clinic (2017)
  - 2. USATF Cross Country Specialist Course
  - 3. USATF Emerging Elite Coaches Camp
- 3. Complete a new USATF Level 1 School and pass the exam

No credit will be provided for any course completed prior to Level 1 certificate date and the Olympic quad start (January 1, 2017).

At time of renewal, USATF membership and SafeSport Training must be current to access the recertification application.

#### (Late) Application Instructions

You must complete all the steps below to recertify as a Level 1 Coach.

- 1. Renew <u>USATF membership</u> for 2021
- 2. Complete latest SafeSport Training
- 3. Complete an approved recertification course
- 4. Submit <u>recertification application</u> and late processing fee (\$55)

Late Level 1 Recertification will continue for a limited time. The on time recertification deadline expired on January 31, 2021.

#### Please note:

- You must complete steps 1-3 before accessing the recertification application
- Please do not email copies of your certificates unless requested
- Please allow five business days for application verification
- Upon approval, your new certificate will be awarded on USATF Campus and valid until December 31, 2024

# Selection Considerations and What You Can Do

Here are some perspectives on what you might do to improve your chances of selection for the major championship events.

Since there are always more qualified applicants than spots available for our championship meets, and though there is never a guarantee of selection, there are steps you can take now to better position yourself for consideration:

 Travel to meets outside of your association. Traveling allows you to see how events are run in other places and learn how to function as a part of a team of officials from



- different places. This can include NCAA meets, conference championship meets, and major relay meets.
- Work USATF Youth, Junior Olympic, and Masters Championship meets. These meets
  give you a chance to work in a championship setting. They also allow other officials get
  a sense of your abilities so that you are a known official and not just a name on an
  application. Most of these meets also include evaluations by head officials which
  provide valuable information to selection committees and to you on how to improve as
  an official.
- Build your resume in a variety of areas. There are some events that require fewer
  officials than others. It is wise to be experienced in multiple areas so that there are
  more spots that you can fill. But make sure that your resume reflects that you have
  worked and are knowledgeable in the areas for which you apply.

Begin applying now and continue to apply. Do not be discouraged if you are not selected. It is not unusual for officials to not be selected every year. But if you do not apply you cannot be selected.

# Youth Chair Report

We held a Lake Erie Association Junior Olympic Championship Cross Country Meet at Columbiana High School. The Meet was held in conjunction with the open/masters meet.

The 2020 National Junior Olympic Cross Country Championships were scheduled for 12/12 -12/13/2020

The Instructions stated that "Masks must be worn at all times. Masks will need to be put on as soon as they finish."

The 2020 Youth Indoor Championships scheduled for 3/20-3/22/2020 in the Ocean Breeze Sports Complex in Staten Island, NY was canceled due to Covid 19 concerns.

A big discussion during the 2020 Meetings surrounded USATF connect and getting Athlete Birth Dates Verified.

The 2021 USATF National Junior Olympic Championship was Scheduled for 7/26 – 8/01/2021 at the University of North Florida, Jacksonville, FL. The meet happened. There was on site Covid PCR testing.

During the 2021 summer youth season and the few months leading up to our association championships it was very difficult to locate facilities that were allowing outside groups to participate at their facilities. In January there was concern whether we could hold meets at all. By the middle of May we were able to get clearance to hold the JO meet at Bedford High School.
